Research:

Thirty years experience in the area of sport and exercise psychology, specifically on the interrelationships among self-efficacy, anxiety, motivation, and performance. Over 130 publications in refereed journals, chapters in books, and a book resulting in 2,817 citations (*h*-index = 27; *g*-index = 49; cites/yr = 82.9). Invited to present this research in several countries, including Botswana, China, Germany, Greece, S. Africa, S. Korea, Spain, and the UK. Served on the National Research Council's Committee on Techniques for the Enhancement of Human Performance to produce a definitive book on learning, remembering, and believing. Listed as one of 8 women who greatly affected the development of the field of sport and exercise psychology in the U.S. (Quiet Competence: Writing Women into the History of Sport and Exercise Psychology, *The Sport Psychologist*, 2010.)
